What is the Quality of Life Community Involvement Program?

The Quality of Life Community Involvement Program was created by the Billings Association of REALTORS® in 2004 with the inception of the Quality of Life Run. The goal is to help raise awareness of and money for non-profits in the community that are working to improve the quality of life for our residents. The Quality of Life program has grown significantly since 2004, including the addition of a second event – Quality of Life Casino Night. To date, more than \$747,000 has been raised for non-profits through these events.

These events were born out of the Quality of Life Program developed by the Montana Association of REALTORS® as a public education and community involvement campaign. REALTORS® are committed to work with state and local elected officials, business groups, housing advocates, our next-door neighbors and others in communities around the state to determine how we can continue to grow while protecting our environment, ensuring economic vitality, and improving our quality of life.

Who should apply to be a beneficiary of the Quality of Life Community Involvement Program?

All applicants should demonstrate an ability to improve the quality of life of the residents of our community while addressing an unmet community need. In addition, applicants will be rated on the overall mission and objectives of the organization, and their financial fitness and sustainability. The recipients of the proceeds of the Quality of Life Community Involvement Program are determined by members of the Billings Association of REALTORS®.

Eligible applicants include nonprofit organizations with an IRS 501(c)(3) tax-exempt status and community-based projects. Non-profits having received a major Quality of Life donation in the past five years are not eligible.

What is the timeline for the Quality of Life Casino Night planning and what is expected of the chosen recipient?

The selection of a recipient and the planning and execution of the Quality of Life Casino Night spans approximately four months. Applications must be submitted by Monday, October 31, and a recipient will be chosen by Tuesday, December 1, and notified thereafter. Periodic meetings of the planning committee are held beginning in February. The selected beneficiary is encouraged to designate a representative to attend these meetings, as well as assist in the promotion and volunteer recruitment for the event. Funds disbursement will occur in May of 2023.

What is the timeline for the Quality of Life Run planning and what is expected of the chosen recipient?

The selection of a recipient and the planning and execution of the Quality of Life Run spans approximately five months. Applications must be submitted by Monday, October 31, and a recipient will be chosen by Tuesday, December 1, and notified thereafter. The planning committee meets periodically beginning in April. The selected beneficiary is encouraged to designate a representative to attend these meetings, as well as assist in the promotion and volunteer recruitment for the race. Funds disbursement will occur in September of 2023.

Application

Only one application is required to be considered for the Quality of Life Casino Night and Run proceeds. It will be assumed that applicants will accept proceeds from either event unless otherwise noted.
